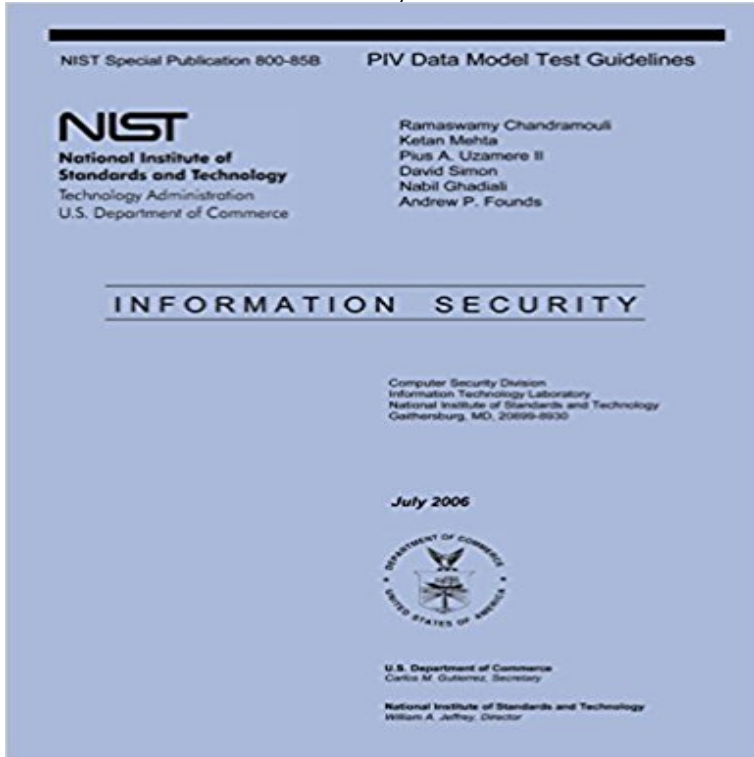


NIST Special Publication 800-85B PIV Data Model Test Guidelines: Information Security
